Instructions to candidates

1. Application form and brochure may be downloaded from the University's website. Candidates should read the brochure carefully and understand the eligibility criteria of admission. Candidates who have appeared / appearing for the final semester / year of qualifying examination may also apply but the proof of the minimum eligibility criteria shall be furnished by September 30, 2020. Those candidates, who do not furnish such proof or not fulfill the minimum eligibility criteria at the time of finalization of admission for any reason including non-declaration of result or revaluation result awaited, their admission will be automatically cancelled. University shall have no obligation to give any notice before such cancellation.
2. Downloaded application form along with the application fee of Rs.2000/- is to be sent to the University. Application fee can be either sent by a demand draft of Rs 2000/- in favour of Registrar, National Law University, Jodhpur or deposited online at the University's website (<http://www.nlujodhpur.ac.in/fee.php>) and the online receipt attached with the application form.
3. The candidates shall fill in all columns of the application form legibly with complete and correct details. Self attested photocopies of the mark sheets for all the years / semesters passed must be enclosed.
4. The candidates shall send the filled in application form with the enclosures by registered post or speed post or courier service so as to reach the **Registrar, National Law University, NH-65, Nagaur Road, Mandore, Jodhpur-342304 Rajasthan**, on or **before 15th June 2020**. Applications received after the last date will not be considered. The envelope containing the application form must be super scribed as APPLICATION FOR MBA (Insurance) ADMISSION 2020.
5. Please note that the **National Law University is a residential University** and all the students selected shall have to compulsorily stay in the **University Halls of Residence**.
6. Selected students shall complete the admission formalities by the dates mentioned in the admission information brochure.
