# 1. ACADEMIC SCHEDULE FOR ACADEMIC SESSION 2018-19:

The academic schedule for the Academic Session 2018-19 commenced with effect from July 1, 2018. The University has a rigorous schedule of study for 20 weeks during every semester. This is the only University in the country having its academic program running 280 days in a year. Academic facilities, however, remain open on the weekly and public holidays as well.

# 2. **NEW ADMISSIONS:**

Admission to LL.B and various L.LM. programs was based on merit through the Common Law Admission Test, 2018 (CLAT-2018) conducted on an all India level on May 13, 2018 by NUALS Kochi. Admission to MBA (Insurance) was on the basis of merit in the MAT (Management Aptitude Test) conducted by All India Management Association (AIMA) & CAT conducted by IIMs. Admission to M.B.A (Insurance Risk Management) was on the basis of merit in the qualifying examinations. # 4. NLUJ SECURES 5TH RANK IN NIRF RANKING FOR LAW SCHOOLS

Hon'ble Minister of Human Resource Development Shri Prakash Javadekar released the NIRF rankings for premier education institutions of the country on 3 April, 2018 whereby National Law University Jodhpur was ranked 5th among the best Law Universities of the country. The University secured 63.50 points based on a comprehensive survey which adjudged the Institution on multifarious parameters including quality, inclusivity and academic outcomes.

National Institutional Ranking Framework (NIRF) was launched by the Ministry of Human Resource Development three years ago and ranks educational institutions on the basis of a methodology including parameters broadly covering Teaching, Learning and Resources; Research and Professional Practices; Graduation Outcomes; Outreach and Inclusivity and Perception.

# 6. CORPORATE LAW SOCIETY REPORT

The Corporate Law Society ("CLS") was founded with the primary objective of providing a platform to foster discussions and debate on issues of corporate law and related topics, inculcate an interest in the subject and allow students to gain a practitioner's perspective. This is facilitated through inviting guests to deliver lectures on developments and emerging trends in the realm of corporate law and related areas of law.

In 2018, CLS organized several successful lectures delivered by eminent alumni of the University and other eminent practitioners, covering topics which are usually outside the purview of classroom discussions including M&A and international investment. The following lectures were conducted:

## 1. Lecture by Mr. Manu Sanan dated February 17, 2018

Mr. Sanan graduated from our University in 2010 and went on to do his LLM from MIDS, Geneva, where he was a Hans Wilsdorf scholar. Currently, he is an Associate at Curtis, Mallet and Prevost, London. Manu addressed the students on "Concept of Arbitrability and its Applicability in Different Situations". Additionally, he also spoke to the students about LLMs and scholarships in general.

# 2. Lecture by Ms. Sagarika Chakraborty dated February 23, 2018

Ms. Chakraborty graduated from our University in 2008 and from the Indian School of Business in 2012 with a Master of Business Administration, Strategy and Marketing degree. Currently, she is the CEO of IIRIS (Indus IntelliRisk and IntelliSense).. She addressed the students on "Risk Management - Exploring New Avenues of Legal Expertise". This was followed by an interactive session wherein she gave some really insightful advice about the reason for her shift in career and the diverse career opportunities available to lawyers.

# 3. Lecture by Mr. Prateek Bhattacharya dated March 12, 2018

Mr. Bhattacharya graduated from our University in 2012 after which he was awarded the Dr. Angela Merkel - Jawaharlal Nehru scholarship to pursue his LL.M. from the Europa Institut, Saarland University. Currently, he is a Senior Associate at ShardulAmarchandMangaldas, New Delhi. He addressed the students on "Merger Control in India". The lecture was followed by a fruitful interactive session on LLMs and scholarships.

# 4. Lecture by Mr. Akshay Sewlikar dated April 13, 2018

Mr. Sewlikar graduated from West Bengal National University of Juridical Sciences, Kolkata in 2015. Currently, he is a legal advisor with the dispute resolution group of Linklaters LLP, London, where he focuses on commercial litigation and arbitration. He delivered a lecture on "Investment Arbitration and the Achmea judgment" wherein he discussed in detail the recent ICSID judgment regarding jurisdiction in international investment arbitration. He provided very useful insights into the practical issues surrounding this area of law.

# 5. Lecture by Ms. Sindhu Venkata Reddy dated August 2, 2018

Ms. Sindhu Venkata Reddy graduated from NLU Jodhpur in 2012. She worked as an Associate with Majmudar& Partners for two years before moving to the United States and working as a Summer Associate with Inventus Law, a Venture Capital and Start-up Law firm in Stanford Research Park. She addressed the students on "Qualifying in Foreign Jurisdictions" wherein she

discussed in detail the various procedures involved in acquiring a dual qualification in UK and USA. She provided very useful insights into the challenges, options, and the practical usefulness of higher education.

# 6. Lecture by Mr. Abhinav Srivastava dated August 24, 2018

Mr. Srivastava graduated from NLU Jodhpur in 2009. Thereafter, he completed his LL.M. in Banking, Corporate Finance and Securities Law from University College London in 2011. Since 2017, he has been part of Conduent, Gurgaon as a Director in Strategic Initiatives. He delivered a lecture on "An Insight into Legal Processes" wherein he discussed the procedure involved when a company enters into an agreement, and the due diligence process it entails. He provided practical insights into the steps, problems, documentation involved in the same.

# 7. Lecture Series by Mr. Kabeer Mathur dated September 18-22, 2018

CLS, in collaboration with the Recruitment and Internship Coordination Committee, conducted a 5 day lecture series by our Alumni, Mr. Mathur, who graduated from NLUJ in 2011. He has since been working at Trilegal, Mumbai, where he is a Senior Associate. He delivered lectures on various topics that a law student joining a corporate firm will be expected to know and understand, including due-diligence, transaction documentation, foreign investments in India, practical implications of legal provisions and negotiation. He engrossed the students by explaining how the academic concepts learnt in law school are practically applied.

# 7. CONSTITUTIONAL LAW SOCIETY REPORT

The Constitutional Law Society at National Law University, Jodhpur was founded to encourage discussion and deep routed understanding in the subject of Constitutional Law. The Society aims to cover aspects of the subject which cannot/are not in the class room due to several constraints. The Society undertakes several activities in the form of special lectures, competitions and general student discussions that augment and further the understanding of the students in the field of Constitutional Law.

Since its establishment in January, 2018 the Society has successfully organized Guest Lectures by Ms. Shylashri Shankar (Senior Fellow, Centre for Policy Research) who spoke on 'From Parliamentary Sovereignty to Activist Courts and Back.. and Back Again: The Tale of Indian

Constitutionalism' and Mr. Sandeep Suresh (Faculty Member, Jindal Global Law School), who addressed the students on 'Gun Control in USA and the 2nd Amendment: The Implications'.

The Society also started a novel initiative in the form of Student Lecture Series wherein the students of the 4th and 5th year, take special lectures for the junior batches. Under the Series, a lecture on 'History of Racial Discrimination in Education in the US: The Journey to the Present' was organized. Contemporary judgments like Indian Lawyers Association v. State of Kerala (Sabarimala), Justice K.S. Puttuswamy v. Union of India (Aadhar) etc. were explained and discussed with the students of the I-IV year as well.

The Society has also organized the 1st Intra-University Constitutional Law Judgment Writing Competition, 2018 wherein the students of the University wrote judgments on a factual proposition on the niche area of privacy law. The winners received prizes in the form of leading books on Constitutional Law and Letters of Appreciation, penned by Prof. I.P. Massey, Dean (Faculty of Law).

Currently, the Society is organizing the 1st Inter-University Constitutional Law Judgment Writing Competition, 2018 wherein over 200 students from law schools across the country will be penning down judgments on a niche area of Constitutional Law. The Proposition for the Competition has been drafted by Mr. Rishabh Sancheti (Advocate, Supreme Court of India) and prizes worth Rs. 50,000/- shall be distributed.

The Society has also started a YouTube Series 'Intra-Vires' wherein members of the Society discuss key Constitutional Law Decisions rendered by the Hon'ble Supreme Court of India and explain it in a manner suited for a common man's understanding. The Society also has its own podcast series titled 'The Chilling Effect' wherein the students discuss key constitutional law topics.

## 8. ORGANIZATION OF CONFERENCES, SEMINARS & COLLOQUIUM

## 1. XI CONVOCATION-

The University organized its XI Convocation for the Batch of 2017 on 21 January, 2018. Prof. Pratap Bhanu Mehta, Vice Chancellor, Asoka University, was the Chief Guest for the occasion; Hon'ble Mr. Justice Pradeep Nandrajog, Chief Justice of Rajasthan High Court and Chancellor of National Law University, Jodhpur presided over the Convocation Proceedings; Prof. Poonam Saxena, Hon'ble Vice Chancellor of NLUJ delivered the Welcome Address and Progress Report of the University. 83 students received the degree of LL.B.; 130 students received post graduate degrees and Doctoral degrees were awarded to 7 scholars in the XI Convocation.

# 2. NATIONAL SEMINAR ON REVISITING THE NEXUS BETWEEN WOMEN'S RIGHT'S, PATRIARCHY AND LEGAL ISSUES-

Centre for Gender Studies organized a national seminar on 'Revisiting the Nexus between Women's Right's, Patriarchy and Legal Issues' on January 27-28, 2018. The presidential address by Hon'ble Vice Chancellor Prof. Poonam Saxena gave insight into how the Supreme Court has interpreted different rights of women in different contexts of Family Law and Property Law. The next two days witnessed 4 panel sessions where participants would present papers on topics ranging from Marital Rape, to the #MeToo campaign, to surrogacy in India, changes in various laws, cyber law issues, situation of the LGBTQ community and criminal justice reforms. Amidst this, there was also an interactive panel discussion with the students where in important issues regarding women's rights and life were deliberated and debated upon. This Seminar was a medium for young change-makers to present their vision to the world. It saw participation from around 70 individuals, spanning over 20 universities across the nation.

# 3. NLUJ-IICA MOOT COURT WORKSHOP-

The Moot Court Committee organized the NLUJ-IICA Moot Court Workshop, from February 21-23, 2018. This workshop was conducted to prepare the officials of the Ministry of Corporate Affairs in various departments for their actual interaction at courts.

During the course of the workshop, the officials were given lectures on procedural laws and thereafter, a moot court competition was conducted for them in order to give them an insight into the practical functioning of the courts.

## 4. WORKSHOP & PIC EXPERT GROUP MEETING FOR RAJASTHAN-

DIPP- IPR CHAIR conducted a workshop on 9<sup>th</sup> March, 2018 to discuss various issues pertaining to the field of Intellectual Property Law. The workshop witnessed speakers from wide ranging fields, viz. government officials, policy makers, field researchers and academicians. Dr. Manu Sikarwar, Project Director, DST, Jaipur emphasized upon creating awareness about IPR policies with special emphasis on encouraging studies in the GI sector. Dr. Shobhlata Udapudi, Professor at GNLU, discussed the issue of technology transfer and its overlap with IP. Ms. Divya Srinivasan, Assistant Manager, CIPAM, Government of India, presented the National IP Policy and talked about how the IPR regime should be strengthened in order to improve India's IP index. She also cited several examples in which the CIPAM has worked towards the effective implementation of IP Policy, such as the inclusion of a chapter with respect to IPR in Class IX NCERT textbook, launch of the hash tag #letstalkip# and collaboration with INTA. Dr. Lalitha Narayanan from Gujarat Institute of Development and Research talked about GI and its importance as a tool which fills the gap of information asymmetry among the sellers and buyers.

# 5. NINTH NLU ANTITRUST LAW MOOT COURT COMPETITION, 2018-

The Moot Court Committee organized the Ninth NLU Antitrust Law Moot Court Competition, 2018 from March 16-18, 2018. The Competition, started in 2010, was conceived as an initiative to increase awareness and interest in Antitrust Law amongst students of law schools across the country. Like every year, it was organized in association with Shardul Amarchand Mangaldas & Co. and the Competition Commission of India, with SCC Online as the Research Partner. In this edition, Octa and Reverse-Octa Rounds were introduced in the Competition to provide more opportunities to the teams to prove their excellence and move forward in the Competition.

## 6. INTRA UNIVERSITY PIL FILING COMPETITION-

The Legal Aid and Awareness Committee (LAAC) and Centre for Litigation Studies (CLiS) organized the second edition of the Intra-University Public Interest Litigation Filing Competition on April 7-8 2018. The objective of the competition was to provide students with exposure to practicalities of the legal profession and make them more sensitive towards the brewing socio-legal concerns and causes. Filing of public interest litigation in the competition provided the apt environment for students to engage in research which was not limited to legal texts and books, but also required groundwork and real-world interactions. The preliminary rounds of the competition were held on April 7, 2018 and were adjudged by learned advocates on the High Court of Judicature for Rajasthan. The arguments were followed by a feed-back session where-in the judges apprised the students of the nuances of filing public interest litigation and about their performance in the rounds. The top six teams broke through to the finals which were held on April 8, 2018 and adjudicated by Hon'ble Justice Dr. P.S. Bhati and Hon'ble Justice Dinesh Mehta, both sitting judges of the High Court of Judicature for Rajasthan. The final rounds closely resembled a real-life court room scenario, with the Hon'ble judges being actively engaged with the arguments, pushing the students to think on their feet as they made their submissions before the bench. The event concluded with an interactive session with the Hon'ble Judges, faculty, participants and students reflecting on the competition, the importance of public interest litigations as a powerful instrument of judicial activism and the increasing need of bona-fide and genuine lawyers taking up the plethora of causes that need addressing in the society.

# 7. NLUJ PARLIAMENTARY DEBATE-

The Debating Society hosted the NLUJ Parliamentary Debate from April 13-15, 2018. The event saw an enthusiastic participation from 36 teams from Delhi, Jaipur, Dehradun, Bangalore and several other cities. National Law University Delhi secured the Winners' trophy and GLC-NIRMA Cross, were runners up. The finals were adjudicated by a seven-member panel of NLUJ PD's best adjudicators. The best external adjudicator was Akash Raj Murthy (RVCE) followed by Karanveer Khurana (independent adjudicator) in the second place and Noumaan Anwer (St Stephens) in the third place. The best internal

adjudicator was Vaishnavi Prasad, while second and third internal adjudicator spots were taken by Devika Sreekumar and Sushant Belvet respectively.

## 8. STUDENT OUTREACH PROGRAMME BY INDIAN ARMY-

As a part of student outreach programme, 2018-19, the team of Indian Army Jodhpur division selected NLUJ to deliver the programme and organised a lecture in the Auditorium of NLUJ on16 July, 2018. The students of UG V, VII, IX Semester and LL.M (all streams) attended this lecture. The objective of the programme was to give an insight to student of NLUJ about Indian Army. This programme was aimed to motivate the young and spirited students to join the prestigious Indian Army. The Programme started with a video which explained the life at Indian Army. This Talk was initiated by Lieutnant Ashish Saini. The presentation was regarding various advantages, privileges and gateways to join Indian Army. At the end of the programme, the students asked lot of questions regarding different induction programme and gateways of Indian Army.

## 9. THE 2ND NLUJ YOUTH PARLIAMENT-

The 2nd NLUJ Youth Parliament organised on August 18th &19th is an initiative by the Debating Society of NLU, Jodhpur to develop a culture of discourse, debate and critical thinking amongst young school students. This year, we had issues such as electoral reforms, data privacy, liberalization and the role of the governor being deliberated in six different committees.

The mandate of the Lok Sabha was to discuss the pressing issue of Regulation on Data Protection and Privacy. The Council of States was tasked with deliberating on Electoral Reforms. The Historic Committee retrospectively discussed the Liberalisation, Privatisation and Globalisation Policy for India, the freeze date for which was July 24, 1991. The school students were required to step into the shoes of the policymakers who took the historic decision of liberalizing the Indian economy in 1991. The National Commission to Review Working of the Constitution (NCRWC) was tasked with deliberating on the Relevancy and the Constitutional Position of the Governor in the Indian democracy, in light of the various developments in formation of governments in Karnataka, Goa, Manipur, etc. The purpose of the Press Council of India was for the students to contemplate on the issues plaguing Indian media at this point of time. The

National Security Advisory Board (NSAB) was tasked with "Assessing India's position on China and the OBOR Initiative. The award for Best Delegation was secured by Jayshree Periwal High School and the Second Best Delegation was from Happy Hours School.

## 10. NATIONAL CONFERENCE ON CORPORATE LAW & GOVERNANCE-

The I NLUJ NFCG National Conference on Corporate Law and Governance was an endeavour by both National Law University Jodhpur and the National Foundation for Corporate Governance to advance discussions and deliberations in the fields of corporate governance. The Conference was held at NLUJ from September 15th to 16th, 2018. It was organized by the Centre for Corporate Governance, NLUJ in association with the Journal on Corporate Law and Governance, NLUJ.

The conference witnessed the participation of around 120 students, academicians and practitioners. Over 63 participants came from outside NLUJ, with participants coming from different corners of the country including from Gujarat, New Delhi, West Bengal, Telangana and Tamil Nadu among other states. The conference also included various paper presentations by certain participants on contemporary issues such as the Kotak committee report and the amendment to the Insolvency and Bankruptcy Code, 2016 among other topics. The Conference was inaugurated by Mr. Bharat Vasani (former Group General Counsel at Tata Sons Limited and currently Senior Partner at Cyril Amarchand Mangaldas).

## 11. III CARTAL CONFERENCE-

The theme for the 3rd CARTAL Conference was "Winds of Change: Securing Harmony in Arbitral Practice" hosted over 29th-30th September at National Law University, Jodhpur in India. In recent years, a rise in conflicts in arbitral practice across the globe in both the investment and the commercial setting has been witnessed. This, in turn, has been accompanied by a rise in the efforts to achieve symmetry between diverse practices across the globe. The Conference sought to address some of these conflicts and the solutions that have been presented, thereby moving towards harmony in arbitral practice. The Panels constituted to probe into the underlying theme were:

- I. The Investment Court System: For Better or for worse?
- II. Cross Institutional Consolidation of Arbitration: The Road Ahead
- III. Guerrilla Tactics in International Arbitration: Where to draw the line?

## 12. NH-65-

The Cultural Committee and Academic Support and Literary Committee, under the aegis of the University administration, organized the fifth edition of our flagship event at NLU – NH-65 2018 from 4<sup>th</sup> to 7<sup>th</sup> October. The fest was a remarkable success and saw enthusiastic participation in the organization and execution by the Committee members. The various cultural and academic events conceptualized by the organization committee of this festival have attracted 706 students from 10 national law universities and 17 other reputed universities. These students participated in 37 highly engaging events. Dr. Naresh Nebhinani, Associate Professor and his team from Department of Psychiatry, All India Institute of Sciences (AIIMS), Jodhpur were invited where intricacies of mental health were discussed and various topics such as Cyber bullying, academic stress, substance abuse, peer pressure, social issue, and many more related topics were addressed which helped the students in understanding the techniques of identifying mental problems and tackling with them.

## 14. YOUTH PARLIAMENT –

Youth Parliament group level competition was held on October 15, 2018 at National Law University Jodhpur. It was organized by Center for Human Welfare and Empowerment headed by Dr. Om Prakash, faculty of Humanities and Social Science. This event was sponsored by Ministry of Parliamentary Affairs, Government of India. The student participants captivated the audience and judges by their enthralling and lively discussion. The event was judged by Dr. Vijay Saigal, who represented Ministry of Parliamentary Affairs and Professor P S Bhati, Professor of Political Science Jai Narayan Vyas University Jodhpur. Six students were declared winner in the event viz. Riyan Vatcha, Anirudh Gotety, Swapnil Srivastav, Raja Reeshav Roy and Kamlesh Bishnoi.

# 15. CONTINUING LEGAL EDUCATION PROGRAMME-

The University, in association with the Bar Council of Rajasthan, organized the Continuing Legal Education Program for Lawyers in the State of Rajasthan (CLEP 2018) between December 26-30, 2018 at Centre for Continuing Legal Education & Rajasthan Advocates Academy, National Law University, Jodhpur. Hon'ble Mr. Justice P C Tatia, Chairperson, Rajasthan State Human Rights Commission was the Chief Guest for the

inaugural function. The programme witnessed whole-hearted participation from aspiring advocates along with some acute insights into the nature of contemporary laws by dynamic resource persons from amongst the faculty and notable jurists. Hon'ble Mr. Justice P.S. Bhati delivered a lecture on "Changing Dynamics of Constitutional Morality" to the avid practitioners of law. Hon'ble Mr. Justice Vineet Kumar Mathur elaborated upon the challenges in the sphere of "Professional Ethics" and reiterated the necessity of advocates following idealism of the highest degree in enhancing the integrity of the profession. The Chief Guest for the Valedictory Ceremony of CLEP 2018 was Hon'ble Mr. P.P. Chaudhary, Union Minister of Law & Justice and Ministry of Corporate Affairs, Govt. of India. Mr. Chaudhary reiterated the importance of constant skill and knowledge updation for advocates and recommended the formation of Advocate Training Academies for all state Bar Councils.

# 9. LEGAL AID AND AWARENESS COMMITTEE REPORT

## 1. 'Mil Kar Karein RTE ko Sarthak' Felicitation

LAAC attempted to maximize the number of Primary level school admissions under Section 12(1)(c) of RTE Act, 2009 from weaker and disadvantaged sections in Jodhpur through organization of a District Level Competition. Under our competition, 'Mil kar karein RTE ko Sarthak', students from various colleges in Jodhpur toiled around the city right from identifying target families till verification of their documents and final confirmation of admission. Their efforts culminated into 128 admissions for academic year 2018.

# 2. Menstrual Hygiene Camp

To tackle the problem of improper management of menstruation, LAAC organized a workshop on Independence Day in Surpura, where women were sensitized about use and benefits of sanitary napkins after a screening of the movie 'Padman'. A survey was also conducted in order to collect data with respect to usage of sanitary napkins by the women of Surpura.

## 3. NH Stall

As an attempt to empower women and encourage them towards financial independence, LAAC initiated a Self-Help group in Surpura wherein a variety of handicraft skills were taught on weekly basis. Member women received necessary skill training and motivation in addition to a monetary sum raised from the sale of the products during the biennial cultural fest of our college, NH-65.

## 4. Plantation Drive

LAAC in collaboration with Rotary Club, Jodhpur organised a plantation drive in the Government Senior Secondary School, Surpura. The drive aimed at cultivating the need and importance of afforestation and maintenance of environment among the people, especially school children. The drive received overwhelming response from students, who were enthusiastic and full of high spirits throughout the activity.

# 5. Workshop on Safeti Pin

Safe neighborhoods free from crime are of primal importance for a nation to progress. A workshop on Technological Solutions for Safety of Women in Cities was organised in collaboration with SafetiPin Ltd. in the University, wherein they demonstrated how SafetiPin app demarcates localities as safe or unsafe based on various parameters collected from crowd sourcing in a bid to make cities more inclusive for women.

## 6. Lex Quest

The team of LAAC organized the second edition of Lex Quest, an Inter-School Quiz Competition, for the students of Jodhpur with the aim to increase legal literacy among the young generation. The competition witnessed participation of over 250 students from classes 9th to 12th. The competition was conducted in two phases, firstly a preliminary written round, for which a guide book "Juris Liber" was provided and later a quiz for the final rounds was conducted to check the knowledge regarding fundamental rights, current affairs and landmark judgements given by the Courts.

# 7. Independence Day Celebration

On the occasion of 72nd Independence day, LAAC became part of the celebration in the village of surpura with the object to connect with people and develop a sense of

solidarity. Dr. Anjali Thanvi, chairperson of LAAC, addressed the people to bring forth any ongoing legal disputes so as to resolve them and help making Surpura a litigation free village, in furtherance to which committee received few matters. Members of Panchayat samiti were told their duty regarding the same.

# 8. Legal Aid Camp

Legal Aid Camp was organized near Chainpura, Jodhpur on 19th August, 2018. Camp was a success in fulfilling its objective of providing access to justice for all. Members received an enthusiastic response from the residents nearby who discussed their legal issues pertaining to corruption inquires, constitutional law, service issues, etc.

# 9. Street Play Marathon on Mental Health Awareness

Multiple street plays were organized in different areas of Jodhpur on 17<sup>th</sup> September, 2018 with the aim of spreading awareness on the issue of growing parental pressure and expectation and the resultant depression among the children. The plays were performed in collaboration with students of National University Students Skill Development Programme (NUSSD). It was followed by exclamatory questioning with the audience through which a discussion on mental health was initiated among the masses. The event proved to be a success when the audience connected themselves with the play and stepped forward to appreciate the initiative through discussion and applause.

All services are designed to support student wellness and emotional flourishing, helping to equip students for wholehearted pursuit of their academic pursuits as well as healthy engagement within their social groups.

## (ix) CENTRE FOR CHILD RIGHTS ADVOCACY-

In the calendar year 2018, the Centre for Child Rights Advocacy conducted fact finding activities in the Juvenile Homes to collect information pertaining to the demographic to be dealt with by the Centre. This included gauging the socio-economic background of the children at the homes, their educational background and their likes & interests. The Centre also interacted with the Juvenile Justice Board and the Child Welfare Committee to get a better understanding of the needs and interests of the children. The Centre also formulated an educational curriculum for imparting primary education to the children at the Juvenile Homes based on the information collected.

# (x) CENTRE FOR LITIGATION STUDIES-

The Centre for Litigation Studies has been working towards organizing activities which can help students to develop a skill set required for the world of litigation. A flagship activity of the center since its inception has been: an annual intra-university Public Interest Ligation Filing Competition. The center also invites practicing advocates to deliver lectures mainly on procedural laws and court practices apart from undertaking research initiatives.

On 13<sup>-</sup>14 October 2018, the Centre organized a two-day drafting workshop for students of the university. Participation was open to students across all batches and required prior registration. The workshop was conducted by the alumni of the University, wherein they offered important tips about nuances of drafting plaints for initiating suits in the lower courts and also in the High Court. The workshop saw participation of more than 50 students from all years of the undergraduate programme.

## (xi) CENTRE FOR ENVIRONMENTAL LAW AND POLICY-

One of the objectives of the Centre for Environmental Law and Policy, National Law University, Jodhpur is the promotion of environmental friendly causes and make the campus more eco-friendly. With that end, the Centre has worked tirelessly to ensure that the campus is polythene and plastic free. The Centre supervised the creation of a plastic free campus by aiding the mess proprietors in finding alternatives to plastic cutlery, plastic straws and polythene bags. As a result, the quantity of plastic generated in the campus has reduced by a large margin.
