ELIGIBILITY

ACADEMIC QUALIFICATION

Applicants must have Minimum 50% marks in class 10th and 12th and a Bachelor's degree in any discipline from a recognized university with at least 50% aggregate marks or equivalent CGPA.

SELECTION CRITERIA

Merit list of the eligible applicants will be prepared based on:

- Percentage or Equivalent percentile in graduation: 70% (Weightage)
- Group discussion: 15% (Weightage)
- Personal interview: 15% (Weightage)



Applicants pursuing final examination of their Bachelor's degree are eligible to apply but on selection they shall be given provisional admission subject to fulfillment of the following conditions:

- Candidates must produce the mark sheet of the final examination in original with minimum marks referred above under eligibility, on or before 31st August, 2024 along with the Migration Certificate from the former educational institution.

PROCEDURE FOR ADMISSION TO MBA (INSURANCE) 2024-2026

- Online application form available at University's website www.nlujodhpur.ac.in is required to be filled by the candidate.
- Application fee of Rs 2000/- is required to be deposited online (<http://www.nlujodhpur.ac.in/fee.php>) and the Receipt No. (Payment Id No.) of the same is to be filled in the online application form.
- Self attested copies of 10th, 12th, Graduation Marksheets and Domicile Certificate should be uploaded online. In case of candidate pursuing Final year / Semester of Graduation, Marksheets upto the last year / semester passed should be uploaded.
- The shortlisted applicants will be called to participate in Group Discussion and Personal Interview scheduled by the University.
- Subsequently, the University shall publish the list of selected applicants along with a waiting list on 10th May, 2024.
- The selected candidate shall be required to deposit the fee on or before 19th May, 2024. If the selected candidate does not deposit the fee on or before 19th May, 2024 then he/she shall lose the opportunity of being admitted and thereafter the vacant seat shall be filled from the waiting list.
- The applicants from the waiting list, if offered an opportunity, shall have to deposit the fees on or before 29th May, 2024.

The Reservation Policy of the University is as follows:

- i. Applicants belonging to SC and ST categories: 15% and 7.5% respectively
- ii. OBC : 21%
- iii. MBC of Rajasthan: 6%
- iv. Specially Abled Persons (SAP): 5%
- v. Domicile Reservation: 25% (Horizontal)

Reservation Policy will be as per existing provisions of the University.
