Policy for Endowment Fund

Purpose: Any Trust, Organisation, Society or any person wishing to constitute the Endowment Fund is required to submit request through a letter or e-mail to the Vice-Chancellor. The endowment can be constituted for the purpose of conducting research, training programmes, conferences, seminars, symposia etc., the advancement of learning, running of course/subject in specified area, or any other purpose as may be mutually agreed between the donor and the University.

Amount: (a) **Option-A-Perpetual Endowment Fund:** Rs.1.00 Crore (in one instalment or upto 4 installments) or as revised by the University from time to time.
(b) **Option-B-Annual Endowment Fund for atleast 5 Years:** Contribution of Rs.15.00 Lacs p.a. for 5 years consecutively.

Above mentioned amount shall be required to be deposited by way of any mode other than cash.

Utilization: A. **For Option (A)** under Perpetual Endowment Fund-Only the interest amount earned by the University from the endowment shall be utilized for various activities, payment of salary, other expenses as mutually decided between the donor and the University. This will be a perpetual Endowment.

B. **For Option (B)** -The annual contribution under yearly amount received shall be utilized by the University for various activities, payment of salary, other expenses as mutually decided between the donor and the University.

Disclaimer

The University reserves the right to change the amount of Perpetual Endowment Fund or Annual Endowment Fund which shall be applicable prospectively.
