Admission Policy for LL.M (One Year) Programme - Foreign Nationals

National Law University, Jodhpur invites applications for admission under Foreign Nationals category for PG (LL.M.) Programme for the academic year 2026-2027. The candidates who are interested in seeking in LL.M Programme, subject to satisfying eligibility criteria and conditions, can directly apply directly to the University.

No of Seats

1. The number of seats available for foreign nationals is 2 (Two).

Eligibility

1. Candidates possessing the citizenship of a foreign country shall ONLY BE considered eligible to seek admission under this category. The candidate must possess citizen of a country other than India and hold a valid passport of a foreign country.
2. The candidates seeking admission in this category are exempted from taking Common Law Admission Test CLAT 2026.
3. Candidates appearing / have appeared in the qualifying examination are eligible to apply for admission but they must produce the marks sheets in original of the qualifying examination on or before one month of the last teaching day mentioned in the academic calendar.
4. The admission of foreign national will be made on the basis of the two components which are mentioned as follows:
 - (i) Academic record of LL.B or equivalent degree with not less than 50% marks or equivalent grade
 - (ii) There shall be an interview.
5. The candidates are required to produce the following documents along the duly filled in Application Form.
 - a) A copy of the valid Foreign Passport
 - b) A copy of the statement of Marks in the qualifying examination in LL.B/B.L etc along with equivalence certificate from Associations of Indian Universities, New Delhi.
 - c) In case, the certificates are in any other foreign language other than English, the candidate must provide a translated copy of the certificate/s duly authorized by the competent authority.
 - d) In cases where the candidates have completed their qualifying examination in a foreign university other than India, the candidates are required to provide complete information of the institution which they have studied earlier. All the certificates should be in English only
 - e) A certificate as proof that the medium of instruction in the previous Institution/University was English.

1 Definition of Foreign National: The candidates who possess citizenship of a country other than India and hold a valid passport of foreign country.

- f) In case of interdisciplinary or integrated (Law) degree courses, the candidate should submit a certificate from their respective institutions, stating that the degree awarded in the qualifying examination was primarily in Law or has equivalence in Bachelors degree in Law.
- g) All the correspondence with regard to admission should be made by email to the admissionsection@nlujodhpur.ac.in

Note: The University reserves the right to change the Intake of students and fees from time to time.

Fee Structure

The Annual Fee Structure for Foreign National Candidate shall be Rs.12,60,000.

(Admission Fee Rs.12, 000 and Security Refundable Fee Rs.17000/- to be paid separately)

Mess Charges shall be applicable separately as per the University policy.
