LAW OF STANDARD ESSENTIAL PATENTS

Standard essential patents ('SEP') have become pivotal as innovators seek to develop new technologies which are interoperable, e.g. Bluetooth, 5G. The mechanism of Fair, Reasonable and Non-Discriminatory ('FRAND') royalty has been developed to balance exclusivity with access, begging the question whether the FRAND royalty can be determined by the courts or when can an

injunction be granted. Analysis is required to determine the extent to which the anti-competitive effects of the SEP. The course represents an exploration of all these facets of SEP's in line with legal developments in Europe, United States of America and India.
