1. ACADEMIC SCHEDULE FOR SESSION 2023-24:

This is the only University in the country having its academic program running 280 days in a year. Academic facilities remain open on the weekly and public holidays as well.

Under Graduate and Post Graduate First Semester classes commenced from July 10, 2023 after the completion of admission process through CLAT.

6. REPORT ON SOCIETIES/COMMITTEES:

(i) CORPORATE LAW SOCIETY REPORT:

The Corporate Law Society was founded in 2014 with the primary objective of providing a platform to foster discussions and debate on issues of corporate law and related topics, inculcate an interest in the subject and allow students to gain a practitioner's perspective. This is facilitated through inviting our eminent alumni to deliver lectures on developments and emerging trends in the realm of corporate law and related areas of law. Following is a summary of the lectures conducted by the CLS for calendar year 2023:

- Mr. Anshuman Mozumdar is currently a Partner in the Corporate and Commercial practice group in the Mumbai office of Khaitan & Co. He addressed the students on March 11, 2023 on "Basics of Mergers & Acquisitions, Private Equity & General Corporate".
- Mr. Rajat Sharma, an alumnus of the Batch of 2020, has carved an impressive career path that
 reflects his expertise across various legal domains. He currently serves as an Associate at Cyril
 Amarchand Mangaldas, one of the leading law firms in India. He addressed the students on
 September 09, 2023 on 'Discussion on the (Competition Amendment) Act, 2023'.
- Ms. Megha Arora is a Partner in the general corporate and M&A practice of JSA, with special focus
 on the projects and energy sector. She addressed the students on September 21, 2023 on 'A
 discussion on Indian Electricity Law Renewable Energy'.

(ii) CONSTITUTIONAL LAW SOCIETY REPORT:

The Constitutional Law Society was founded in the year 2018 to encourage discussion and debate in the subject of Constitutional Law. The Society undertakes several activities in the form of special lectures, competitions and general student discussions that augment and further the understanding of the students in the field of Constitutional Law.

- The Society organized a Conclave on "Babasaheb Ambedkar: His Life and Constitutional Legacy" and the student community was addressed by Prof Anurag Bhaskar and Adv. Disha Wadekar on April 21, 2023. The speakers discussed the personal struggles of Babasaheb Ambedkar and how his personal life had an immense impact on his work as a Constitutional Law scholar and how it led him to be one of the major proponents of social justice as a constitutional goal.
- An informal discussion was organized on the case of Kannaian Naidu and Ors v. Kamsala Ammal and Ors. on August 23, 2023.

- An informal discussion on the case of Navtej Singh Johar v. Union of India was organized (in collaboration with the Centre for Gender Studies, NLUJ) on 6 September, 2023.
- A paper discussion was organised on 16 Oct 2023, on a paper authored by Amal Sethi titled 'Reassessing Public Participation in Constitution-Making Process'.

(iii) LEGAL AID & AWARENESS COMMITTEE REPORT:

A. Essay Writing Competition in Government School, Surpura [January 25, 2023]

The Committee under the aegis of Pro-Bono Initiative of the Ministry of Law and Justice, Government of India along with the Surpura Community Library Committee celebrated the event of Republic Day and National Voters' Day at the Surpura Community Library by conducting an essay competition on the theme "Spreading Awareness on Electoral Participation: A Step Towards Creating a Well-Informed Citizenry". Within this theme, students were provided with a hypothetical scenario to write on.

B. RTE-Paper Presentation & Discussion Series MilkarKarein RTE Ko Sarthak [February 3-4, 2023]

One of the Committee's major projects is 'MilkarKarein RTE ko Sarthak.' It is a competition organized by our Committee since 2018 to make the benefits under Right to Education Act ["RTE Act"] accessible to the target group consisting of weaker and disadvantaged sections of the society. The Competition aims to bolster the impact of the beneficiary provision of Section 12(1)(c) of the RTE Act which provides for reservation of 25% seats in the private schools- to actualize the idea of universal education. The Legal Aid and Awareness Committee of National Law University, Jodhpur conducted a paper presentation and discussion series on the implementation of the RTE Act, 2009 across different regions in the nation. Under this programme, the committee released a call for paper presentation to premier law institutes in India to discuss the implementation of the RTE Act, 2009. The discussion series included paper submissions by the participating universities on the state of RTE in their respective region by conducting the survey.

Through this event, LAAC aimed to put together the suggestion, recommendations, data, opinions and statistics collected through this series and prepared a comprehensive RTE Report or Policy which was launched on the last day of the event.

C. Workshop On 'Law as A Career Option' For Students of Shree Jain Public School, Bikaner [February 16. 2023]

The Committee conducted a pro-bono workshop for the students of Shree Jain Public school, Bikaner. The workshop was a part of the school tour undertaken by the students who had opted for legal studies in their senior secondary education and it was explicitly planned in a way to cater towards improving their understanding of legal education while carving a path for them in the field of law. The students were then made to engage with a few college professors who asked them questions regarding their future career choices and clarified any doubts they had about the same. After the tour and general interaction, the workshop on "Law as a career choice" was conducted.

D. Workshop On Government Schemes in Surpura [February 19, 2023]

The Committee took an initiative to bridge the gap between the government schemes and prospective beneficiaries by conducting a workshop in the village Surpura on 19th February 2023. The purpose of this workshop was to provide information about the schemes run by the Government of India and the State Government of Rajasthan for Women, Senior Citizens, Students et cetera.

E. NH-65 X LAAC: Stall with Sambhali Trust [March 17-19, 2023]

The Legal Aid and Awareness Committee organized a stall to showcase the talents and creativity of women in handicrafts at the Cultural and Literary Fest of NLU Jodhpur, NH-65, 2023. It was jointly organized with Sambhali Trust, an NGO empowering marginalized women and children in Rajasthan. The objective of the event was to empower and uplift women from disadvantaged communities by promoting their skills. The stall was thus designed to showcase various handicrafts such as embroidery, block printing, beadwork, and other handmade products. The committee invited women from Sambhali Trust's vocational training programs to participate in and exhibit their unique crafts. The stall was attractively decorated with traditional Rajasthani art and was designed to draw the attention of passersby. The Trust set up the Sambhali Boutique to enhance the ability of the women and adolescent girls graduating from their empowerment centers to support themselves and their families. One product, one seamstress is the motto behind each product, where one person makes an article from start to finish.

F. Computer Lab Inauguration at Surpura [MARCH 28, 2023]

With the aim to bridge the digital divide and provide equal opportunities for everyone in Surpura, the Computer Lab was inaugurated by the Hon'ble Vice Chancellor, Dr. Poonam Saxena and the event witnessed the presence of Additional Advocate General, Shri Pankaj Sharma, Additional CEO, Shri Mahesh Chaudhary, Sarpanch, Gram Sevika at the Panchayat Bhavan at Surpura village.

With the establishment of Community Library, the committee realised that apart from inculcating reading habits among the students, it was significant for the students to be addressed with the technological know-how. Hence, the committee dedicated itself for the construction and development of the computer lab. The work is not done yet as this project is ever-expanding and a continuous one. The committee aims to begin a training programme for skill development regarding the basic knowledge of computer functioning. The committee also plans to extend the beneficiaries of the lab to include the women of the village for their betterment in the field of technology.

G. Winner At GNLU's Legal Services Forum [April 13-14 2023]

The Legal Aid & Awareness Committee participated in the Annual Legal Services Forum, organized by Gandhinagar National Law University's Legal Services Committee from 13th to 14th April 2023. The aim of the event was to bridge the gap between academics and grassroots-level fieldwork undertaken by legal aid centres and provide a unique platform to engage in discourse for systemic issues posed to legal aid initiatives.

LAAC was represented by Ms Tasneem Fatema and Mr Nigam Vrat Attri from the Batch of 2026, and Mrs Anjali Thanvi, the Chairperson and faculty advisor of the Committee. They conducted a presentation explaining the multifarious activities conducted by LAAC including inter alia, RTE Paper Presentation & Discussion Series, Legal Aid Camps, Jan Sunwai and Nukkad Naataks. They also proposed the future activities that LAAC aims to realize and elaborated on the mission plan and resources needed for the same, including Roshan Zameer (Empowering the Voices of the Displaced Refugees), Open Air Prisons, Sahas (Empowering Transgender Voices), Shilpjeevika (Skill-Developments for the women of Surpura), Lex Quest & NLUJ-Inter PIL Competition.

LAAC was felicitated as the Winner of the GNLU Legal Services Funding Grant to honour and support the socio-legal initiatives of the Committee. The grant includes a reward of Rs. 25,000/-, a trophy and a certificate of merit. LAAC envisages utilizing this grant to reach newer heights in the field of legal services.

H. Ambedkar Jayanti Celebrations [April 14, 2023]

The committee invited the children of Suprura to participate in an inspiring and edifying session which aimed at promoting education and awareness about the life of Dr. Bhim Rao Ambedkar. During the event, the committee presented a small documentary showcasing Dr BR Ambedkar's remarkable life and his contributions towards the upliftment of marginalized communities in India. The children were captivated by the content and drew inspiration from the struggles and lessons of this great leader.

I. Training under "Designing Innovative Solutions and Holistic Access to Justice (DISHA)"

The DISHA Scheme, under Department of Justice, endeavors to consolidate various components of Access to Justice currently undertaken, with the goal of addressing gaps in justice delivery. The Pan India Action Plan, a component of DISHA, outlines Legal Literacy and Legal Awareness programs designed to adopt a multi-stakeholder, progressive, and transformative approach.

The One-Day Workshop on Legal Literacy and Legal Awareness was organised on October 9, 2023 under the aegis of Department of Justice, Ministry of Law and Justice, Government of India by National Law University, Jodhpur in association with Centre for Environmental Law, Education, Research and Advocacy (CEERA), National Law School of India University (NLSIU). The workshop was graced by esteemed speakers such as Adv. Gopal Sandhu, Mr. Vikas Gehlot, Prof. Sairam Bhat and Dr. Deendayal Purohit who shared their valuable insights on several aspects of pro-bono legal aid with real life examples to make the session engaging. Prof. Sairam Bhat, Professor of Law & Coordinator, CEERA, NLSIU emphasised on the fact that Legal aid must be preventive in nature and not remedial. The workshop aimed at highlighting the issues faced by marginalised society while accessing legal aid and access to legal education. The workshop was a huge success as 175 attendees were present in the workshop.



J. Informative Session on Alcoholism and Drug Abuse

The Ministry of Social Justice & Empowerment has been implementing the Central Sector Scheme for Prevention of Alcoholism and Substance (Drug) Abuse since 1985-86 with the objectives of creating awareness and educate people about the ill-effects of alcoholism and substance abuse and for providing the whole range of community-based services for indemnification, motivation, counselling, de-addiction, after care and rehabilitation for whole person Recovery (WPR) of addicts. In accordance with the directives issued by the Juvenile Justice Committee, Rajasthan High Court, and Rajasthan State Legal Services Authority, Rajasthan High Court, Jaipur, Justice Vijay Vishnoi, a distinguished Judge at the Rajasthan High Court, presided over a specialized event on the 31st of October 2023 at the Town Hall of Rajasthan Sangeet Natya Academy. LAAC presented an informative session on the topic "Alcoholism and Substance Abuse" during the event.



K. PROJECT SAAHAS: Empowering Transgender Persons Through Legal Literacy & Services

The Legal Aid & Awareness Committee ["LAAC"], NLU Jodhpur collaborated with Prasar Bharati's Akashvani - All India Radio, Jodhpur to record an episode aimed at disseminating awareness about transgender persons and the structural and emotional barriers that hinder their progress. This segment aired on 20th October 2023, on All India Radio's Channel: Surya Nagri Akashvani Jodhpur [531 AM Rajasthan]. The radio-segment was the beginning of the first leg of our Project Saahas: Empowering Transgender Persons Through Legal Literacy & Services.

L. Nukkad Natak on Chunav Jagrukta

On October 15, 2023, the Legal Aid and Awareness Committee organized a Nukkad Natak (street play) in the rural area of Mathania, located approximately 30 kilometers away from the University campus. The primary objective of this initiative was to promote awareness and educate the local community about their voting rights, emphasizing the importance of free and fair elections in Rajasthan without external influence and the distribution of freebies. The Nukkad Natak staged in Mathania resonated profoundly with the local community, drawing an enthusiastic audience of approximately 70 to 80 individuals from the village and its neighboring areas. This notable turnout underscored the efficacy of the initiative, affirming its ability to effectively connect with the intended audience.


M. Chunav Jagrukta (Voting Awareness) Podcast

The podcast was in furtherance of the initiative of Chunnav Jagrukta, under which the members of the committee generate awareness among the local community about the importance of voting in elections. The Podcast was styled as a conversation between a mother and daughter, and was titled as 'Mera Phela vote'. The script was written in a way as to include all the influences that affect the voting rights and providing a pathway to choose ideal vote.

A. LECTURE BY DR. ANTONIO MARZAL YETANO

E. XIV NLUJ ANTI-TRUST LAW MOOT COURT COMPETITION

Under the patronage of the esteemed Competition Commission of India, and in collaboration with Cyril Amarchand Mangaldas, as well as our knowledge partners, SCC Online and Eastern Book Company, the Fourteenth NLU Antitrust Law Moot Court Competition, 2023 was successfully held from February 17-19, 2023. Mr. Mukesh Chand, Senior Legal Counsel, Economic Laws Practice spoke on Harmonising Disputes: Assessing the 2023 Mediation Act's Proficiency in Resolving Disputes and its Influence on the Banking and Financial Sector; Dr. Mukulita Vijayawargiya, Legal Advisor to Comptroller and Auditor General of India extolled on Legislative Drafting Techniques (Including Interpretation of Statutes); Mr. Bharat Chugh, Advocate lectured on Navigating Legal Frontiers: Al and Smart Contracts in the Fintech Landscape; Mr. Sumant Batra, Insolvency Lawyer and International Fellow, American College of Bankruptcy dwelt on the intricacies of Insolvency and Bankruptcy Code - Hits, Misses & New Targets; Mr. Sanjay Khan Nagra, Partner, Khaitan & Co. lectured on Key regulatory aspects impacting Fintechs - special focus on interplay between Fintechs and DPDP.



X. INLUJ-KHAITAN & CO. CORPORATE LAW REVIEW SUMMIT

The I NLUJ-Khaitan & Co Corporate Law Review Summit, 2023, was organized by the Journal on Corporate Law and Governance at National Law University, Jodhpur, on October 14-15 2023. The event was sponsored by the Reserve Bank of India, in collaboration with the Insolvency and Bankruptcy Board of India (IBBI), and Khaitan & Co, along with SCC Online - Eastern Book Company as the knowledge partners for the summit. The Inaugural Session had a keynote address by Mr. Santosh Kumar Shukla,

II. Interactive Session with Prof. Timothy Endicott

The members of the Constitutional Law and Administration Law Journal (CALJ) had an interactive session with one of the advisors of the Journal, Prof. Timothy Endicott. Renowned for his contribution to the field of administrative law and constitutional law, Prof. Endicott, currently is the Vinerian Professor of English Law at the University of Oxford. The session unfolded as a dynamic question-and-answer exchange, where the scholars had the opportunity to glean insights from Prof. Endicott's wealth of expertise in constitutional law and administrative matters.

III. Commemoration of Adoption of Constitution Day

The Center, under the aegis of the Department of Legal Affairs, Ministry of Law & Justice, conducted an intra-university essay competition to commemorate the adoption of the Constitution of India on November 26, 1949. The essay competition was based on two themes, the first being Women in Indian Constituent Assembly: Reflections on Diversity in Constitution Making and the second B.N Rau: The Unsung Architect of the Indian Constitution.

IV. Writ[e] & Talk podcast

- a. Mr. Shrutanjaya Bhardwaj in conversation with Mr. Prakhar Raghuvanshi, gave an insight into his research paper, "Preventive Detention, Habeas Corpus, and Delay at the Apex Court: An Empirical Study". The episode discusses Mr. Bhardwaj's paper, which draws from an empirical study on the delay in adjudication of habeas corpus petitions in preventive detention cases. He provides a fascinating analysis of successful habeas corpus petitions; with the three indicators chosen for the study ultimately suggesting that the writ is often rendered ineffectual.
- b. Mr. Lalit Panda, in a conversation with Ms. Sayantani Bagchi, gave an insight into his research paper, "The Weight of Secrets: Assessing the Regulatory Burden for Informational Privacy in India". He discussed the intricate challenges of data protection, emphasizing the need for a unified cross-sectorial regulatory framework that aligns with the unique characteristics of personal data. With a focus on the Draft Personal Data Protection Bill, the importance of considering regulatory burdens and implementing accountability and responsive regulation is highlighted.
- c. Dr. Seema Kazi, in a conversation with Ms. Sayantani Bagchi, gave an insight into his research paper, "Women, Gender Politics and Resistance in Kashmir".

The paper dissects the impact of Article 370's revocation on Kashmiri women, probing beyond political ramifications. Unveiling the disparity between state claims and women's

rights, it unravels the misogynist gendered narratives in hyper nationalist rhetoric post-revocation and unveils the collective resistance of Kashmiri women through local reporting.

Representation of LGBTQ+ in the Courts was a virtual panel discussion organized by the Centre for Gender Studies in the month of April. The panel consisted of two esteemed figures closely associated with the cause, Mx. Muskan Tibrewala and Mr. Mihir Samson. Mx Tibrewala is an Associate at the Chambers of Ms. Karuna Nundy and is also an advocate at the Hon'ble Supreme Court of India. Mr. Samson is a queer rights activist and lawyer based in New Delhi. Previously with the Lawyers Collective, he was involved in the research and litigation for Naz v. NCT Delhi, 2009, and Koushal v. Naz, 2013.

III. Session on Prevention of Sexual Harassment

Session on Prevention of Sexual Harassment (PoSH) was organized by the Center for Gender Studies. The session was conducted in February by Ms. Ray to spread awareness about the issue among students. Ms. Ray is the managing partner of TRS Law Offices, Delhi, and appears regularly before the High Courts and the Supreme Court of the country.

The discussion commenced with an overview of the LGBTQIA+ rights movement in India, emphasizing the long-fought battle that ultimately led to the reading down of Section 377 of the Indian Penal Code. The speakers delved into the legal complexities and social implications of the Navtej Singh Johar judgment. They highlighted how the judgment not only decriminalised homosexuality but also underscored the need to dismantle systemic discrimination against LGBTQIA+individuals.
